### Meeting called to Order at 6:30pm by Chair Com MacDonald

## Com MacDonald reads the land acknowledgement to Mi'kmaq People.

#### 1. Addition to Agenda

- Agenda was distributed to the Commission on Apr 4<sup>th</sup>, 2024.
- Addition to Agenda:
  - o Community Club will be moved to the top of the agenda

#### 2. Request of conflict of interest

No conflict of interest was disclosed.

#### 3. Approval of Minutes

Minutes of the regular meeting on Mar 20<sup>th</sup> were distributed to the commission by email on Apr 8<sup>th</sup>. No corrections, errors, omissions, or additions were stated.

#### **Community Club**

- Meeting of Community Club Committee was on Sunday March 24<sup>th</sup>
- Members at the meeting were Tammy MacSween, Sarah MacEachern, Patti Garland and Com MacDonald
- Topics of the meeting:
  - Property Maintenance: Removal of hazardous goods, cutting bushes, make tennis court free of hazards. Village PW will organize a clean up. The Baddeck Academy O2 class will help to clean up the property
  - o Committee Structure
    - Village terms of references were provided to the committee

- There is 5 voting members on the committee, plus Com MacDonald and there is room for 4 more members
- Call for expression of interest for more members will be announced in the next newsletter, on facebook and on the website. Potential members can submit their name and a short note why they are interested in becoming a member and what knowledge and experience they can bring to the committee. The commission will review and nominate members.

#### Project Planning

- Application for Placemaking funding up to \$25,000 will be sent for the Community Club project planning. This funding can finance a consultant for the planning phase.
- The village is eligible to apply for the grant on its own
- A motion was moved by Com McNeil and seconded by Com MacKinnon that the Village of Baddeck will apply for the maximum amount of the placemaking fund for the Community Club development. All in Favour – Motion carried.
- A motion was moved by Com MacDonald and seconded by Com Crowder to accept the Community Club Report as presented. All in Favour – Motion carried.

#### 4. Business arising from the Minutes:

- EDPC:
  - A letter was sent to John Bain regarding the concerns of capacity issues on water and sewer in Baddeck in December 2023. The village commission did not get a response yet and will follow up on the letter.

#### Area Advisory Committee

- Com Crowder reported, the committee was meeting but did not have a quorum. Topics were tabled to the next meeting
- Victoria Council Village Commission Meeting
  - The list of potential topics was included in the package
    - Property next to WWTP: It should be discussed with council if there is interest to hand this piece of land over to the village. In case of an expansion of the WWTP it might be a great to have more land
    - Road allotment Community Club
    - Request for support of potential expansion of Village boundaries (end of Alexander Dr, Harvey Dr, End of MacLeod St, Alderwood Ln)
    - Air BNB Marketing Levy:
      - Are these properties going to be taxed commercial?
      - How much impact on the revenue does the marketing levy have on village taxes? There are 18 properties within the village that were noted
    - Vending by-law:
      - The vending by-law was never approved by the minister
      - It should be discussed again, because if it is a village by-law it is very limited.

- Clarification with the municipality about a strategy if planning and zoning of the municipality is considering vending and signage by-laws.
   How can the village be part of it? How is it going to be enforced?
- The village does not have the capacity to enforce the by-laws.
- Conversation about coordination of open and closed businesses when cruise ships are coming in.
  - Cruise ship tourists are coming to Baddeck and not a lot of businesses are open. It was stated that coordination of cruiseship visits need to be coordinated with the businesses.
  - BABTA will be contacted to discuss the topic.
- Sidewalks and road repairs: Before these are repaired the piping needs to be identified. To make sure the paving is not done before we replaced piping.
- VM will pass along the list of topics to council. For the meeting on April 15<sup>th</sup>.
- VM will ask VC-CAO about the format of the meeting

#### Grant applications:

#### - MLA Keith Bain visit



#### Waterfront Baddeck (WFB)

- Minutes of the last meeting were sent to the commission
- None of the members were present at the meeting, so no presentation of the report.
- Floating docks are going in the water on Monday, April 29<sup>th</sup>.
- Discussion about shelter on the wharf for Winstar:
  - Recommendation of WFB is not to put any structure out on the wharf
  - Discussion about wharf structures. Most of the wharfs have structures. It should be discussed if a structure on the wharf would be a benefit for the village wharf.
  - A request will be made by the VM to WFB to clarify the topic.
- Boardwalk Structure:
  - Steve Ross, VM and Com Crowder had a look at it. Areas of concerns need to be addressed. It is probably not worth to repair the section short term.
  - Commission will ask for clarity on the boardwalk as well.



- A request will be made by the VM to WFB to clarify the topic.
- WFB Report was not accepted because more clarification is needed.

#### **Public Works Report**

- Report was presented by Scott MacLeod
- No additions made
- A motion was moved by Com Crowder and seconded by Com McNeil to accept the Public Works Report as presented. All in Favour – Motion carried.

#### **Accessibility Advisory Committee**

- Next meeting is Monday April 15<sup>th</sup>. A tour through town will be organized to snap pictures of accessibility issues (physical barriers, visual barriers, auditory barriers, psychological barriers, etc.) in town.
- Summary of the last meeting was presented by Com Crowder.
- A motion was moved by Com McNeil and seconded by Com MacKinnon to accept the Accessibility Advisory Committee Report as presented. All in Favour – Motion carried.

#### Audit Committee:

- Meeting was on April 3<sup>rd</sup>. Com Crowder presented a summary of the AC Meeting.
- The framework on topics the village should look at was put together.
- Minutes were not provided yet.
- Financial statements were presented and discussed.
- A motion was moved by Com McNeil and seconded by Com MacKinnon to accept the Audit Committee Report as presented. All in Favour – Motion carried.

- The meeting had no quorum.
- Com Crowder presented a summary of the report
- A motion was moved by Com McNeil and seconded by Com MacKinnon to accept the Baddeck Area Advisory Committee Report as presented. All in Favour – Motion carried.

#### - Climate Task Force:


Was hosted at bold and was well attended.


- A draft budget was presented for 2024 which will be sent to the commission by email.
