### A Resident seeking nomination must be:

- A Canadian Citizen
- At least 18 years of age
- A resident of the Village of Baddeck for at least 6 months prior to election day

Nominees must be nominated using the nomination form (located on the back of this page, via [www.baddeckvillage.ca](http://www.baddeckvillage.ca) or at the village office) that includes the signatures of five electors supporting the nomination. These electors must be eligible to vote in a municipal election and have resided in the village for at least 6 months prior. The nomination form must then be signed by the candidate, notarized and presented at the village office prior to the closing of the nomination period.

The **NOMINATION PERIOD** will open on **Thursday JUNE 6<sup>th</sup>, 2024 at 8:30 a.m.** and close on **Thursday JUNE 13<sup>th</sup>, 2024 at 4:30 p.m.**

If three or more qualified candidates are nominated, an **ELECTION** will be held **Saturday JULY 7<sup>th</sup>, 2024 from 9 a.m. to 7p.m.** The **advanced poll** will be held on **Tuesday, JULY 2<sup>nd</sup>, 2024 from 11 a.m.-7 p.m.**

The polling office will be located at the **Village Office at 492 Chebucto Street, Baddeck.** Bring proof of identification and proof of residence to the poll.
